INVESTMENT PHILOSOPHY

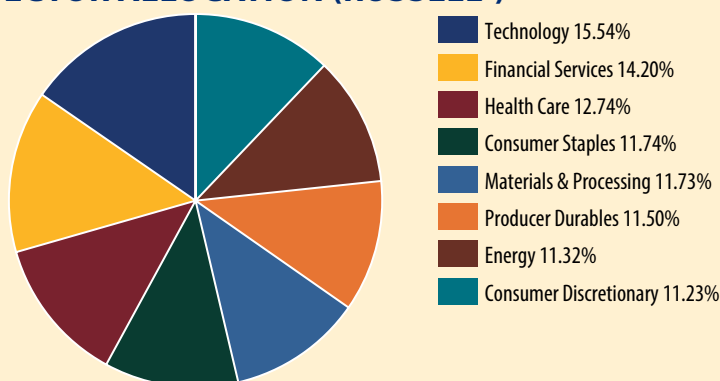
- We believe equal exposure across sectors offers attractive risk adjusted returns;

INVESTMENT STRATEGY OVERVIEW

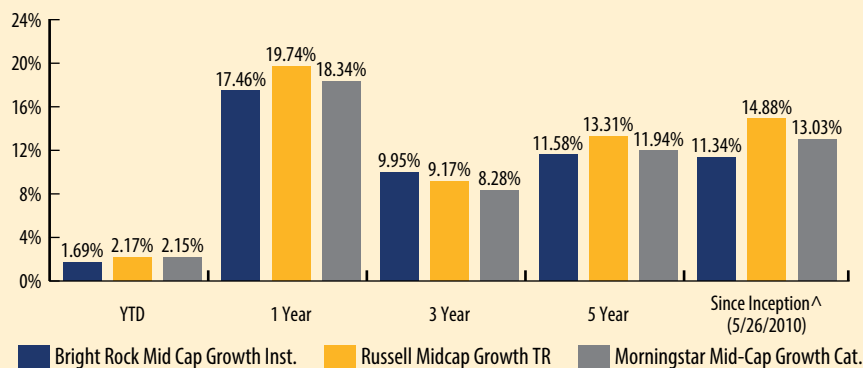

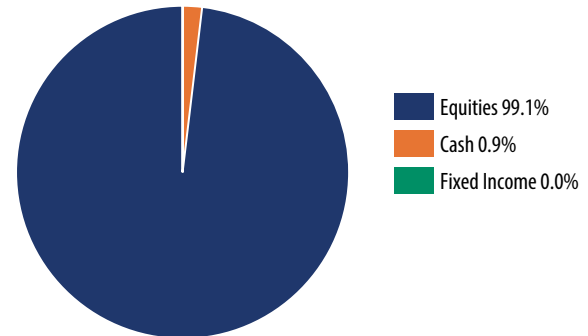

Important Disclosures

Alpha: A statistic that measures the difference between the Fund's actual returns and its expected performance, given its level of risk as measured by beta. The difference is expressed as an annual percentage. **Average Market Cap:** The mean market capitalization (value of outstanding shares) of a basket of stocks, taking into account the relative weight of each investment. **Beta:** A statistic that measures the volatility of the fund, as compared to that of the overall market. **Sharpe Ratio:** The Sharpe ratio is calculated by subtracting the risk-free rate, such as that of the 10-year U.S. Treasury bond from the rate of return for a portfolio and dividing the result by the standard deviation of the portfolio returns. **Standard Deviation:** A statistical measure of portfolio risk used to measure variability of total return around an average, over a specified period of time. The greater the standard deviation over the period, the wider the variability or range of returns and hence, the greater the fund's volatility. **Tracking Error:** A divergence between the price behavior of a position or a portfolio and the price behavior of a benchmark. This is often in the context of a hedge or mutual fund that did not work as effectively as intended, creating an unexpected profit or loss instead. **Upside/Downside Market Capture** measures a manager's performance in up/down markets relative to the fund's benchmark. **Active Share:** Represents the proportion of portfolio holdings that differ from those in the benchmark index.

The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating™ for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating™ metrics. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. The Mid Cap Growth Fund (BQMGX)(BQMIX) received 4 stars and 3 stars among the following numbers of Mid Cap Growth Category funds over the following time periods: 549 and 485 in the last three- and five-year periods respectively ending 03/31/2018. **Past performance is not a guarantee of future results.**
